October 24, 2018 (South Kortright, NY) – The Global Federation of Animal Sanctuaries (GFAS), the only globally recognized organization providing standards for identifying legitimate animal sanctuaries, awarded Verified status to Rosemary Farm Sanctuary, Inc. as of October 24, 2018.

Verification means that Rosemary Farm Sanctuary, Inc. meets the criteria of a true equine sanctuary/rescue and is providing humane and responsible care of the animals. To be awarded Verified status, an organization must meet GFAS's rigorous and peer-reviewed animal care standards which are confirmed by a site visit and they must also adhere to a demanding set of ethical and operational principles. The Verification status also provides a clear and trusted means for the public, donors and grantors to recognize Rosemary Farm Sanctuary, Inc. as an exceptional organization.

"We are proud to announce the recent Verification of Rosemary Farm Sanctuary, Inc.," said Valerie Taylor, GFAS Program Director-Equine. "Located on beautiful, enriching property, Rosemary Farm provides high quality lifetime sanctuary care to equines-in-need, in addition to facilitating equine adoptions. The organization has also put solid business and fundraising practices in place, and is poised for tremendous growth, which will benefit an increased number of equines."
