

Illinois Horse Rescue of Will County of Peotone, Illinois is Verified by Global Federation of Animal Sanctuaries



January 23, 2019 (Peotone, IL) – The Global Federation of Animal Sanctuaries (GFAS), the only globally recognized organization providing standards for identifying legitimate animal sanctuaries, awarded Verified status to Illinois Horse Rescue of Will County as of January 17, 2019.

Verification means that Illinois Horse Rescue of Will County meets the criteria of a true equine sanctuary/rescue and is providing humane and responsible care of the animals. To be awarded Verified status, an organization must meet GFAS's rigorous and peer-reviewed animal care standards which are confirmed by a site visit and they must also adhere to a demanding set of

ethical and operational principles. The Verification status also provides a clear and trusted means for the public, donors and grantors to recognize Illinois Horse Rescue of Will County as an exceptional organization.

“We are proud to announce the recent Verification of Illinois Horse Rescue of Will County,” said Valerie Taylor, GFAS Program Director-Equine. “The rehabilitation and re-training programs this organization provides to equines-in-need are thorough and comprehensive. This creates an ideal path for equines to be placed in permanent, adoptive homes, and allows Illinois Horse Rescue of Will County to expand their capacity for care-helping many more horses over time.”.
